

# **Livestock Evaluation**

National FFA Organization | Career and Leadership Development Events

### Purpose

The livestock evaluation career development event provides the opportunity to learn and apply livestock industry and production priorities through evaluation and selection of beef cattle, swine, sheep and meat goats.

### **Objectives**

Participants in the West Tennessee FFA Livestock Evaluation Career Development Event will be able to

- Make accurate observations of livestock.
- Determine the desirable traits in market and breeding livestock.
- Make logical decisions based on these observations.
- Discuss and defend their decisions for their placings.
- Understand desirable selection, production, management and marketing techniques for livestock.
- Understand and interpret the value of performance data based on industry standards.
- Select and market livestock that will satisfy consumer demands and provide increased economic returns to producers while meeting the needs of the industry.
- Proficiently communicate using the terminology of the industry and the consumer.
- Associate with professionals in the industry.
- Utilize current technology as it relates to the livestock industry.
- Develop employability skills for future agricultural career choices.

### **Event Rules**

- Each team will be comprised of four members. All four scores will be used to determine the total team score.
- FFA Official Dress is required for the state event.
- Any participant in possession of an electronic device in the event area is subject to disqualification.

### **Event Format**

#### EQUIPMENT

Materials students must provide:

• Two No. 2 pencils.

Equipment provided by West Tennessee FFA:

- All paper will be provided. Participants are not to bring any paper.
- All other necessary materials will be provided by the event committee.
- Scantrons used during the event will be provided by West TN FFA.

#### **INDIVIDUAL ACTIVITIES (200 POINTS)**

#### Keep Cull (50 points each with 200 points total)

Keep/cull classes: This will be paper-based only. This may be beef, swine, sheep, or meat goats. Participants will be provided a scenario and performance data and will be required to select the four best animals from the eight using performance data. Performance criteria, when used, shall be based on current industry standards. Previous keep/cull information will be posted for reference during future events.

#### Livestock evaluation/placing classes (50 points/class, 400 points total)

Eight classes of four animals each will be placed using a computerized scorecard. Classes may be breeding or market animals from beef, swine, sheep or meat goat species. At least one class will include the use of production/performance data.

#### Oral reasons (50 points/class, 150 points total)

Three sets of oral reasons will be designated by the event superintendent at the beginning of the event. One set of reasons will be given on the production data class. Reasons will be given after all classes have been placed. Participants will be provided paper to take notes on each reason class for preparation. Use of notes during the reason presentation is strongly discouraged.

## Scoring

Activity	Individual Points	Team Points
Classes – 8 at 50 points each	400	1,600
Reasons – 3 at 50 points each	150	600
Keep/cull – 1 at 50 points each	50	200
MAXIMUM POSSIBLE POINTS	600	2,400

All team member scores will be used to determine final team placing.

#### TIEBREAKERS

If ties occur, the following events, in order, will be used to determine individual and team outcomes:

- 1. Total of oral reasons.
- 2. Total of placing classes.
- 3. Total of keep/cull classes.

### Rubric for reasons

- 40-50pts no use of notes, reasons are very understandable and descriptive of the class, <u>do not</u> sound canned, this score range should include close to the correct (within a pair switch) placing as well.
- 35-39pts no use of notes, average description of the class but are more scattered and harder to follow, harder to understand as far as volume and terminology,
- 30-34pts no use of notes, poor description of class, poor terminology, long pauses, has trouble finishing set of reasons.
- 25-29pts has introduction of the class, tries to complete the reasons set but cannot, very nervous, forgets placings, very poor use of terminology, no structure for set of reasons, very unprepared.
- 20-24pts only gives a class introduction and placings but does so without the use of notes, almost no description of the class,
- 10-19pts read their notes at any point.
- 0-10 walk up and say they don't know what they are doing and walk away. (we hope this does not happen)
